



**INVITATION TO BID FOR 2020 48TH PUBLIC BIDDING:
PROCUREMENT OF IT SUPPLIES AND EQUIPMENT
FOR 2021 CONSUMPTION**

1. The *Bataan General Hospital and Medical Center*, through the *Internally Generated Fund 2021* intends to apply the sum of *Php 4,382,650.00* being the ABC to payments under the contract for *PROCUREMENT OF IT SUPPLIES AND EQUIPMENT FOR 2021 CONSUMPTION / BGHMCPB-2020-48-001*. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The *Bataan General Hospital and Medical Center* now invites bids for the above Procurement Project. Delivery of the Goods is required as follows:

Bidders should have completed, within *two years* from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).

3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
 - a. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.
4. Prospective Bidders may obtain further information from *BGHMC BAC Secretariat Office* and inspect the Bidding Documents at the address given below during *weekdays excluding holidays, 8:00am to 5:00pm*.
5. A complete set of Bidding Documents may be acquired by interested Bidders on *December 30, 2020 –January 19, 2021* from the given address and website(s) below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of the following:

The *Bataan General Hospital and Medical Center* will hold a Pre-Bid Conference¹ on *January 07, 2021, 1:30 pm* at *Ground Floor OPD Bldg. of Bataan General Hospital and Medical Center, Manahan St., Tenejero, Balanga City, Bataan*, in case this venue is not available at the time of the Pre-bid Conference, noticed will be posted in the BAC Office, which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat through manual submission at the office address indicated below on or before *January 19, 2021, 11:00am*. Late bids shall not be accepted.
8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 14.
9. Bid opening shall be on *January 19, 2021, 1:30pm* at the given address below. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.

The *Bataan General Hospital and Medical Center* reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.


