



SECTION I. INVITATION TO BID

1. Bataan General Hospital, through the *General Appropriation Act (GAA) and Income Account CY 2016* intends to apply the sum of **Php 14,803,591.20** being the Approved Budget for the Contract (ABC) to payments under the contract for *Medical Supplies, Medical Imaging Supplies and Laboratory Supplies*.

Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. BGH now invites bids for *Medical Supplies, Medical Imaging Supplies and Laboratory Supplies*. Delivery of the Goods is required on a staggered basis, within **10 calendar days from the receipt of Notice to Proceed and Purchase Order**.

Bidders should have completed, within **two (2) years** prior to the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.

4. Interested bidders may obtain further information from BGH Bids and Awards Committee Secretariat and inspect the Bidding Documents at the address given below from 8:00am to 5:00pm, Mondays to Fridays excluding holidays.

A complete set of Bidding Documents may be acquired by interested Bidders on *June 15, 2016 to July 11, 2016* from the address below and upon payment of a **non-refundable** fee for the Bidding Documents in the amount of:

5. BGH will hold a Pre-bid Conference on **June 29, 2016, 10:00am** at the 3rd Floor Annex, Audio Visual Conference Room of Bataan General Hospital, Manahan Street, Tenejero, Balanga City, Bataan. Open only to all interested parties who have purchased the Bidding Documents.

6. Bids must be delivered to the address below on or before **July 11, 2016, 8:30am**. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause 18**.

7. Bid opening shall be on **July 11, 2016, 10:00am**, at 3rd Floor Annex, Audio Visual Conference Room of Bataan General Hospital, Manahan Street, Tenejero, Balanga City, Bataan. Bids will be opened in the presence of the Bidders’ representatives who choose to attend at the address below. Late bids shall not be accepted.

8. BGH reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
