



SECTION I. INVITATION TO BID

1. Bataan General Hospital, through the *Income Account CY 2016* intends to apply the sum of **Php 5,720,662.02** being the Approved Budget for the Contract (ABC) to payments under the contract for *Food Supplies*.
Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. BGH now invites bids for *Food Supplies*.
Delivery of the Goods is required on *as needed basis* using an ordering agreement.
Bidders should have completed, within *two (2) years* prior to the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through Ordering Agreement procedures using a non-discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".
Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.
4. Interested bidders may obtain further information from BGH Bids and Awards Committee Secretariat and inspect the Bidding Documents at the address given below from 8:00am to 5:00pm, Mondays to Fridays excluding holidays.
A complete set of Bidding Documents may be acquired by interested Bidders on *August 27, 2016 to September 20, 2016* from the address below and upon payment of a **non-refundable** fee for the Bidding Documents in the amount of Php500.00
It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the non-refundable fee for the Bidding Documents not later than the submission of their bids.
5. BGH will hold a Pre-bid Conference on *September 08, 2016, 2:00pm* at the 3rd Floor Annex, Audio Visual Conference Room of Bataan General Hospital, Manahan Street, Tenejero, Balanga City, Bataan. Open only to all interested parties who have purchased the Bidding Documents.
6. Bids must be delivered to the address below on or before *September 20, 2016, 8:30am*.
All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 18.
7. Bid opening shall be on *September 20, 2016, 2:00pm*, at 3rd Floor Annex, Audio Visual Conference Room of Bataan General Hospital, Manahan Street, Tenejero, Balanga City, Bataan. Bids will be opened in the presence of the Bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.
8. BGH reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
