INVITATION TO BID FOR 41st Public Bidding for Medical Supplies

1. Bataan General Hospital, through the **Income Account CY 2018** intends to apply the sum of **Php 3,434,861.04** being the Approved Budget for the Contract (ABC) to payments under the contract for **Procurement of Medical Supplies**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. BGH now invites bids for Procurement of Medical Supplies. Delivery is required ten (10) calendar days after the receipt of Notice to Proceed. Bidders should have completed, within two (2) years prior to the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”.
Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.
Interested bidders may obtain further information from BGH Bids and Awards Committee Secretariat and inspect the Bidding Documents at the address given below from 8:00am to 5:00pm, Mondays to Fridays excluding holidays.
4. A complete set of Bidding Documents may be acquired by interested Bidders on September 10, 2018 to October 2, 2018, before the bid opening from the address below and upon payment of a fee for the Bidding Documents in the amount of:

6. *BGH* will hold a Pre-Bid Conference on **September 18, 2018, 10:00am** at 3rd Floor Annex, Audio Visual Conference Room of Bataan General Hospital, Manahan Street, Tenejero, Balanga City, Bataan which shall be open to prospective bidders. Bidders who wish to attend the Pre-Bid Conference shall either present a copy of receipt of bid documents or a proof of authority to represent their company such as Secretary's Certificate (Corporation); Resolution in case of JVA signed by all JV partners; Partnership Resolution from the General Manager or President; Special Power of Attorney (Sole Proprietorship).

7. Bids must be delivered to the address below on or before October 2, 2018 8:30am. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 18.

Bid opening shall be on **October 2, 2018, 10:00am** at 3rd Floor Annex, Audio Visual Conference Room of Bataan General Hospital, Manahan Street, Tenejero, Balanga City, Bataan . Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Bidders/representative shall present proof of authority to represent their company such as Secretary's Certificate (Corporation); Resolution in case of JVA signed by all JV partner; Partnership Resolution from the General Manager or President; Special Power of Attorney (Sole Proprietorship). Late bids shall not be accepted.

8. *BGH* reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
