



## Section I. Invitation to Bid

ITB 18-37-001

1. The BATAAN GENERAL HOSPITAL, through the Income Account and General Appropriations Act CY 2018<sup>1</sup> intends to apply the sum of P90,460,000.00 being the Approved Budget for the Contract (ABC) to payments under the contract for Construction of Five (5) Storey Multi-Specialty Building (Phase 2).

Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The *Bataan General Hospital* now invites contractors registered with and classified by the Philippine Contractors Accreditation Board (PCAB) to apply to bid for the hereunder project:

Approved Budget for the Contract:	P90,460,000.00
Contract Duration:	One Hundred Eighty (180) Calendar Days

Bidders should have completed a contract similar to the Project within ten (10) years. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

Prospective Bidder should possess a valid PCAB license minimum category requirement Medium A, Category B for General Building, have completed a similar contract with a value of at least **fifty percent (50%)** of the ABC and have key personnel and equipment (listed in the Eligibility Forms) available for the execution of the contract. The BAC will use non-discretionary pass/fail criteria in the Eligibility Check/Screening as well as the Preliminary Examinations of Bids. The BAC will conduct post qualification of the lowest calculated bid.

and Award of the Contract shall be governed by the pertinent provisions of 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184).

The prospective bidders are also required to present authorization letter and valid ID of authorized representative with original and photocopy of PCAB License and Certificate of PhilGEPS registration.

The *Bataan General Hospital* reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
