Invitation to Bid for 2018 54th Public Bidding for the Construction of Perimeter Fence and Parking Lot with Guard House and Storm Drainage System

1. The *Bataan General Hospital* through the *Internally Generated Fund CY 2018* intends to apply the sum of *Php 15,646,000.00* being the Approved Budget for the Contract (ABC) to payments under the contract for *2018 54th Public Bidding for the Construction of Perimeter Fence and Parking Lot with Guard House and Storm Drainage System*. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The *Bataan General Hospital* now invites bids for *Construction of Perimeter Fence and Parking Lot with Guard House and Storm Drainage System*.² Completion of the Works is required within 180 calendar days. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the “Government Procurement Reform Act.”
4. Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.
4. Interested bidders may obtain further information from *Bataan General Hospital* and inspect the Bidding Documents at the address given below during *weekdays excluding holidays, 8:00am to 5:00pm*.
5. A complete set of Bidding Documents may be acquired by interested Bidders on December 05, 2018 to January 03, 2018 from the address below and upon payment of a fee for the Bidding Documents in the amount of Php 10,000.00

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

² A brief description of the scope of Works should be provided, including quantities, location of project, and other information necessary to enable potential bidders to decide whether or not to respond to the invitation.

6. The **Bataan General Hospital** will hold a Pre-Bid Conference³ on **December 13, 2018, 10:00AM** at **3rd Floor Annex, Audio Visual Conference Room of Bataan General Hospital, Manahan St., Tenejero Balanga City, Bataan** (in case this venue is not available at the time of the Pre-Bid Conference, notice will be posted in the BAC office), which shall be open to prospective bidders.

7. Bids must be duly received by the BAC Secretariat at the address below on or before **January 03, 2019, 8:30am**. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 18.

Bid opening shall be on **January 03, 2019, 10:00am** at 3rd Floor Annex, Audio Visual Conference Room of Bataan General Hospital, Manahan St., Tenejero Balanga City, Bataan (in case this venue is not available at the time of the Bid Opening, notice will be posted in the BAC office). Late bids shall not be accepted. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Bidders/representative shall present the receipt of bidding documents or any proof of authority to represent their company such as Secretary's Certificate (Corporation); Resolution in case of JVA signed by all JV partner; Partnership Resolution from the General Manager or President; Special Power of Attorney (Sole Proprietorship).

8. Prospective Bidder should possess a valid PCAB license minimum category B or size range Medium A for General Building, have completed a similar contract with a value of at least fifty percent (50%) of the ABC and have key personnel and equipment (listed in the Eligibility Forms) available for the execution of the contract

9. The Bataan General Hospital reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
