



**INVITATION TO BID FOR 2018 42ND Public Bidding for
Relocation of IHOMP Data Center and other ICT
Equipment to Finance Office and Upgrade of Network
Switches and Backbone Connection to Fiber Optic with
VLAN Configuration.**

1. The **Bataan General Hospital**, through the *Income Account CY 2018* intends to apply the sum of *Php2,000,000.00* being the Approved Budget for the Contract (ABC) to payments under the contract for *Relocation of IHOMP Data Center and other ICT Equipment to Finance Office and Upgrade of Network Switches and Backbone Connection to Fiber Optic with VLAN Configuration*.
- Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The **Bataan General Hospital** now invites bids for *Relocation of IHOMP Data Center and other ICT equipment to Finance Office and Upgrade of Network Switches and Backbone Connection to Fiber Optic with VLAN Configuration*.³ Delivery and Installation is required *thirty (30) calendar days* after the receipt of Notice to Proceed. Bidders should have completed, within *two (2) years* from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”.
4. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.
4. Interested bidders may obtain further information from *Bataan General Hospital* and inspect the Bidding Documents at the address given below during *weekdays excluding holidays, 8:00am to 5:00pm*.
5. A complete set of Bidding Documents may be acquired by interested Bidders on *September 21, 2018 to October 16, 2018* from the address below and upon payment of a fee for the Bidding Documents in the amount of One Thousand Pesos Only (Php1,000.00).

³ A brief description of the type(s) of Goods should be provided, including quantities, location of project, and other information necessary to enable potential bidders to decide whether or not to respond to the invitation.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPs) and the website of the Procuring Entity, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

6. The **Bataan General Hospital** will hold a Pre-Bid Conference⁴ on **October 3, 2018, 2:00PM** at **3rd Floor Annex, Audio Visual Conference Room of Bataan General Hospital, Manahan St., Tenejero Balanga City, Bataan** (in case this venue is not available at the time of the Pre-Bid Conference, notice will be posted in the BAC office), which shall be open to prospective bidders.

7. Bids must be duly received by the BAC Secretariat at the address below on or before **October 16, 2018, 8:30AM**. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 18.

Bid opening shall be on **October 16, 2018, Tuesday, 10:00AM**, at **3rd Floor Annex, Audio Visual Conference Room of Bataan General Hospital, Manahan St., Tenejero Balanga City, Bataan** (in case this venue is not available at the time of the Bid Opening, notice will be posted in the BAC office). Late bids shall not be accepted. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Bidders/representative shall present the receipt of bidding documents or any proof of authority to represent their company such as Secretary's Certificate (Corporation); Resolution in case of JVA signed by all JV partner; Partnership Resolution from the General Manager or President; Special Power of Attorney (Sole Proprietorship).

8. BGH reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
